1.0	Welcome and Introductions	Date	
	The meeting opened at 12.03pm. The Chair welcomed attendees to the meeting and advised of guest speakers Layna Harris from the Small Business Commissioner's office, and Dragana Houston from SWLEP, later in the agenda. Apologies were noted.

	 Findings were as follows: job postings across Swindon and Wiltshire had continued to recover over the six months to October. After a steep month-on-month decline of nearly 50% in April 2020, the number of job postings improved slightly each month with October 2020 broadly in line with the October 2019 levels; apprenticeship postings had recovered more slowly. After a nearly 90% drop on the previous month in April, slight increases were reported in May, June and July. After the introduction of the new government incentive, nearly

a four-fold month-on-month increase was reported in August, reaching levels in line with August 2019. Since then, however, the apprenticeship postings had declined, with October 2020 nearly 40% below the October 2019;

- **job postings**, when broken down by industry sector, show that only Human Health & Social Work Activities reported year-on-year increases during April to October 2020 in Swindon and Wiltshire. The largest declines were seen in Accommodation & Food Service (-4%, as proportion of all jobs), Wholesale & Retail (-2%) and Information & Communication (-2%);
- **Swindon**, which during April to October 2019 accounted for nearly 50% of all job vacancies across the Swindon and Wiltshire LEP area, saw the largest year-on-year decline during the April to October 2020 period, accounting for just under 45% of all vacancies. Other towns with significant declines in job postings during this period were: Salisbury, Chippenham and Malmesbury. However, five towns reported year-on-year increases during April to October 2020: Corsham, Trowbridge, Westbury, Royal Wootton Bassett, and Warminster; and
- the claimant count data, which included people claiming Jobseeker's Allowance as well as those that claimed Universal Credit, is used as a headline indicator of the number of people unemployed. Swindon, and Wiltshire even more so, were continuing to perform better than the national average. In October, nearly 12,000 in Wiltshire (4% of Wiltshire's residents aged 16-64) were claiming these benefits, compared to c. 8,000 in Swindon (5.7% of those aged 16-64) in Swindon and 6.3% for England overall. However, more young people appeared in the claimant count in Wiltshire at 22% compared to Swindon and the national average of 20%.

The question was raised on what the projections for the next five months would look like. The true situation was being masked by all the government programmes, and this would then change in the spring once all funding and support were removed. New jobs were projected to be in cyber, hydrogen and green jobs, but the situation was changing rapidly and SWLEP would continue to monitor. There were some vacancies which were difficult to fill with more time spent on repeat adverts. SWLEP would be looking at the "intensity" of these job adverts and ascertaining whether there were any transferable skills. The notional sense was that some sectors were thriving whilst others were at severe risk. SWLEP would be undertaking an in-depth sector specific analysis.

KG advised of the situation where businesses in the area had been applying to become trust mark companies to complete work for the green homes grant. However, it was costing £10,000 to be registered.

PB advised of the European Regional Development Fund project which allocated funding for low carbon for companies offering advice to businesses about making their business more energy efficient. SWLEP would put details on the website when available.

4.0 Good News Stories

The Chair asked for "Good News Stories" around the area and relayed one example.

A farm outside Pewsey had been selling fruit and vegetables from a garage.
 As a result of the pandemic, sales had increased, and they had converted a barn and were now turning themselves into a farm shop.

- FSB call with Chairman. Small businesses had managed to pivot positively
- Kez Garner from Trowbridge Chamber of Commerce added that a lot of the businesses were adapting or starting from home because they had more time and using the grants and loans to invest in new ways of working. The platform of choice was Instagram which they were using to launch their products and services.
- ST stated that the latest round of MakeUK Regional Advisory Boards had shown that businesses were improving, and orders were up in most cases. Some had quoted that they were having the best month ever.

Action: ST to provide report when available for circulation to the group.

- PB commented that although not enough businesses were accessing grants from Innovate UK, a Chippenham-based company had recently secured £500,000 research grant to make a plastic welding tool. It was not yet a commercially viable product.
- Additionally, a Swindon-based company (Scaled) was using technology to manufacture a 3D printed electric car constructed from recycled plastic.
- DTM advised that she was indeed working with Scaled at the moment.
 Another company was a satellite-based intelligence company which had grown significantly and had worked from home successfully. Business West was supporting them with management and leadership to manage 35 staff from home, but it operated across the globe. The company expected to increase staff by 20-30 in the next year and had just bought its first satellite which would launch from Exeter.
- LB stated that Innovate UK was funding more businesses than ever. Covid fast rqach and rapid response grants. Get Swindon and Wiltshire businesses to have more sight of the grants available.
- RS from Cool Ventures advised of a food & drink business previously based in Bath which had recently relocated to Wiltshire and had diversified by delivering cream teas to homes.
- Paul O'Collins from the European Enterprise Network (EEN) stated that it
 was assisting companies across the patch with IP audit which were highly
 subsidised.

5.0 Risk register and business communications

RFi and CP spoke to the meeting. Additional information about businesses was seeping through, but not a great deal about large business redundancies or site closures. Information flow from Swindon Borough Council to the Growth Hub was working well for small businesses.

The latest grant schemes as a result of the recent lockdown had just been launched and the next round was up and live across both Local Authorities.

Wiltshire Council's Local Restrictions Support Grant (LRSG) went live on Friday 13 November; these were rates-based for enterprises which were required to close under national restrictions between 5 November to 2 December. The payments would be made in series of four-week batches.

Those businesses not eligible for these grants, would continue to be signposted to the Growth Hub navigators for additional support. The Government had informed LAs that the discretionary fund of money needed to last until March 2022, so they would have to stretch that out.

There was still strong focus on supporting the high street and retail. Companies were looking for alternative viable routes to market. Campaigns included:

- shop safe,
- shop local, and
- support Wiltshire etc.

Looking at increasing messages around the local theme, to add volume to those businesses on the run up to Christmas.

- FSB was also running a shop small to make a big difference campaign to encourage people to support their local retailers. To get involved, use the #ilovesmallbusiness hashtag online to celebrate those local, independent businesses that are special to you and customers can share images of their purchases by using the hashtag #shopherethisChristmas.
- There was work with David Andrews of VisitWiltshire on the shop local message for key visitor attractions to support those businesses in the area. Gathering together the best information, not creating something new, but consolidating the offering.
- RF mentioned another collaboration in the Wye Valley with its food & drink producers.

Small Business Commissioner

Layla Harris (LH) from the Small Business Commissioner's Office joined the meeting and explained the role of the organisation.

- The service provided was free
- Available to companies with 50 employees or less to assist in obtaining payment from businesses with more than 50 employees
- Invoices must have been submitted within the last 12 months.
- Did not deal with construction issues as they were handled by a separate set of legislation however, the office would still signpost companies to support
- The office would take on the small business's complaint and investigate the reasons for non-payment when other means had been exhausted
- The office did not have the powers to make the larger business pay but it could make legally binding recommendations which were published in a report which was publicly available. Name and shame.
- £7.4m had been recovered for small businesses since inception
- There was also an educational element to its service. A staff member was allocated to different geographical areas and to discuss business practice, such as legal contracts and terms and conditions, so the businesses did not get into a non-paying position in the first place.
- The Office was making contact with Growth Hubs and LEPs to establish working relationships and joining up for events, together to raise awareness.
