








Green Increased Demand

Retrofitting Council Housing and vulnerable residents

- Retrofitting all our own Council Housing to EPC rating B this is done through contractors, and training in-house staff.
- Level 5 Retrofit co-ordinator training through the Retrofit Academy https://www.retrofitacademy.org/l5-methods-of-study/
- A number of housing staff Level 3 Award in Energy Awareness through the NEA: https://www.nea.org.uk/work-with-us/training/supported-e-learning/level-3-award-in-energy-awareness/
- LADS2 Targeted at those in fuel poverty £10k to retrofit their home managed through City Energy. Requires PAS2035, with installers trained to Level 2.



Planning

- Affordable homes developers being encouraged to build zero carbon new build
- Council working with Community Land Trust to build zero carbon homes
- Electric car charging points to be installed in new builds electricians need to be able to do this, and increased demand



Management roles and skills

- Carbon literacy staff training
- Green procurement skills
- Carbon and energy managers
- Data management
- Funding bids
- Managing changing roles and expectations



Decarbonising Fleet

- Electric car charging points to be installed in new builds - electricians need to be able to do this, and cope with increased demand
- Retraining for electric/low carbon fleet 25%
 will be electric by end of 2022 smaller vehicles.
- Larger vehicles will need to move onto alternate fuel.



Engagement with Businesses

The vast majority of businesses in Wiltshire are small, and very diverse.

Wiltshire would welcome a strong lead on green skills for businesses and support an emphasis on Green Skills in any new SWLEP Skills Plan

Larger companies – climate and carbon reduction are a key item, and they will accordingly often have 'green' skills at the professional level.

Constraints may come around supplier capacity: to deliver new buildings, physical systems and refits, fleet supply/transition, new infra etc
