



Your Application: Important information

Application timeline

- Closing date 23:59 23rd November 2018
- Outline application assessment due around February 2019
- Full applications due around April 2019
- Appraised before going to ESIF sub-Committee
- Funding agreement / project visit July 2019
- Realistic start date is July 2019 but could start "at risk" sooner
- Duration typically 3 years for revenue-spending projects

Government's 'Extended Guarantee'

- ESIF programmes to run 'until their natural end'
- Projects can be agreed up to the end of December 2020 and then run for 3 years thereafter
- 'Extended Guarantee' is regardless of EU-UK Withdrawal Agreement

- Priority 3 all investment priorities apply

Current ERDF delivery

- SME Growth project
- Due to close November 2019
- Wiltshire Council holds SME Growth ERDF contract
- Framework providers deliver Inspire, Oxford Innovations, BusinessWest, Cool Ventures and links to The Enterprise Network via Wiltshire Council
- Specialist ERDF projects LMAP, Innovate2 Succeed, Export for Growth, Life Sciences Hub + calls for digital growth and manufacturing projects

SME Support: Local Priorities

Core requirements

- Start-up service
- Scale-up service
- Productivity focused (digitalisation)
- Start-up support for financially and socially excluded people 'inclusive growth'
- Closing supply chain gaps Brexit response rules of origin, SM, customs, etc

Delivery methods

- Mentoring scheme
- I-2-I support / assistance
- I-to-many workshops, etc
- Diagnostic / information
- Grants and wider finance access to investment partners

- £0.5m ERDF on offer £1.0m project over 3 years
- Priority 3 investment priorities 3c and 3d apply (so not really for start-ups)

Current ERDF delivery

- LMAP Local Manufacturing Advisory Project
- Due to close September 2019
- SW MAS (manufacturing advisory service) holds ERDF regional contract for LMAP
- Delivery is by SWMAS local leads
- Other specialist ERDF projects Innovate2 Succeed, Export for Growth, Life Sciences Hub + calls for digital growth and manufacturing projects

Manufacturing Support: Local Priorities

A specialised and tailored package of support to assist SME manufacturers for investment finance, and implement measures to increase productivity and growth

In particular:

- Effective leadership, management and business strategy
- Introduction of new or improved products, technologies or ways of working,
- Transforming with digital capability and enabling technologies ('Industry 4.0')
- Investment in physical capital, e.g. machinery and equipment
- Seizing new business opportunities / supply chain opportunities
- SEP Strategic Objective 5 broad aims for business support, inward investment and smart specialisation underpinned by Growth Hub

Growth Hub – single point of entry – providing targeted information for SMEs

- Add value to the offer eg; diagnostic, signposting and referral services
- Complementary to the overall offer and not creating a rival service

- Priority I investment priority I b applies (revenue expenditure should be the focus)

Digital Growth: Local Priorities

Taking forward aspects of the Swindon and Wiltshire Digital Capabilities Strategy

'Digital capabilities' = "those factors that work together to promote technology-driven productivity growth"

Strategic recommendations for:

- I. Digital Creation services, creators, security, software / hardware
- 2. Digital Adoption innovation of goods & services via digitisation
- 3. Digital Foundations skills and infrastructure for inclusivity

Most recommendations are relevant and appear as local priorities in the call.

Digital Foundations is about creating positive conditions for growth and inclusiveness as technology advances

(Broadband provision should not be part of project expenditure)

Research infrastructure: Before you start

Basic details

- Call ref: OC33R18P 0793
- £2.5m ERDF on offer £5.0m project
- Priority I investment priorities Ia and Ib apply (capex & revenue expenditure possible)

Current ERDF delivery

Specialist ERDF projects – Porton Science Incubator – life sciences focus

Investment opportunities (inexhaustive ideas for innovation infrastructure)

Build on growth in the area – investment could be linked to:

- Salisbury Plain and Boscombe Down for civilian applications of aerospace / defence tech
- Follow Digital Capabilities Strategy evidence creativity & digitalisation physical hub
- Take forward <u>Cyber Resilience Alliance</u> SIA particularly around Corsham
- Link to the proposed £200m investment by Dyson for EV production at Hullavington
- Link to Agritech taking into account the proposed centre at Lackham College
- For low carbon goods and services, eg; linked to the <u>Hydrogen Hub</u> and clean growth
- Institute of Technology development, recognising emerging Higher Education strategy
- <u>Porton Science Park</u> on health and life sciences or related disciplines
- Add value to <u>The Hive</u> Uni. of Bath Building Research facility at Wroughton





Research infrastructure: Local Priorities

Overarching priority is for capital investment in facilities and an organisation to improve productivity and accelerate economic growth by bringing together research, commercial insight and academic and innovation expertise for the benefit of firms in Swindon and Wiltshire

- Higher spec facilities (*which could include*) labs, ultrafast broadband capability, testing and proving facilities, flexible workspaces, plus networking space
- Build on current innovation assets relevant to local key sector industries
- Develop exchange between SMEs and innovative businesses and researchers
- Establish links to national Catapult centres, centres of excellence,
- Connect to relevant higher education institutions, researchers and academics
- Enhance the innovation capacity within Swindon and Wiltshire's SMEs
- Increase demand from Swindon and Wiltshire's SMEs for R&D activity
- Equip SMEs for end-to-end R&D for new products and process innovations





Your application: Local Strategic Fit

- Call document section 3.2 'Local development need'
- ESIF Strategy has informed the call for projects
- <u>Strategic Economic Plan</u> is overarching SWLEP strategy
- Digital capabilities strategy, and other evidence is relevant to your outline application
- Industrial Strategy will be relevant to your application
- National eligibility criteria in <u>ERDF operational programme</u>
- Local Sub-committee advises Managing Authority on application assessments, but it does not take decisions







Your application: Process

The ERDF Application Process

- Outline Application MA Assessment ESIF Sub Committee advice
- Managing Authority decision invite full application, technical support
- Full Application Appraisal ESIF Sub Committee advice
- Managing Authority final decision time limited
- Grant Funding Agreement (GFA) pre-GFA conditions contract
- Project Inception Visit (PIV) and On the Spot Verification
- **Project Management** Claims ongoing compliance audit checks

Your application: National priorities

Project activity 'indicative actions' – Operational Programme

- Call document section 3.3 highly relevant for eligibility
- Proposals must be within the scope of the eligible activities
- Coherent applications begin with proposed activities to deliver call priorities
- Eligibility guidance

Costs

- Coherent applicants link costs to proposed activities
- Costs should be set out in the Application Annex
- Outline Application should make reasonably accurate explanation of costs
- Full Application requires a greater degree of accuracy
- Develop budget throughout the process until grant funding agreement
- Procurements planned should be documented in Application Annex

Beneficiaries

- Assisting SME beneficiary is standard unit for outputs CO01
- PAI an element of selection based on smart specialisation/ key sectors
- PAI Larger firms can be involved for increased investment and collaborations





Your Application: National Priorities

<u>Outputs</u>

- Causation Input (costs) and Outputs (deliverables)
- Outputs are discreet to each **priority**
- Do not chase outputs, make a reasonable case
- Full list of local ERDF targets

Value for Money

- Assessed by Managing Authority key to continuing project post-Brexit
- Input monies / no. of outputs = vfm figure
- Programme ready reckoners provide scores on effectiveness and efficiency
 - Priority I CO0I = £20,000 / business assist
 - Priority 3 CO01 = £8,500 / business assist
- Explain what you're trying to achieve and how you'll go about it
- Be prepared to make your case / flex your options





Your application: Delivery

Expenditure

- Capital or revenue follows indicative actions
- Project budget separate accounts

Partners

- Lead partner is responsible for the project holds contract "GFA"
- Legal agreements between lead partner and delivery partners
- Particular activities to be carried out by either:
 - Delivery Partner in agreement with lead
 - Procured and delivered via a contracted party







Your Application: Technical

State Aid

- Determines what subsidies are allowed in Single Market
- Consider GBER for an appropriate exemption for the grant
- De minimis support for SMEs assisted may apply
- You will need formal advice at Full Application stage
- What is your role? lead or partner, intermediary or recipient

Procurement

- Competition rules apply tenders must be published
- Rules apply to partners and grant-aided beneficiaries

Income generation

- To prevent incompatibility of grant with rules on subsidies
- Project income is discounted / grant clawback applies







Your Application: Outline assessment

Gateway assessment

- I. Is the applicant eligible to use funds from ERDF?
- 2. Is the activity and spending eligible within the rules?
- 3. Is the proposal relevant to the call for proposal?

Core Selection criteria

- A. Strategic fit with ERDF programme, national priorities, etc
- B. Value for money
- C. Deliverability
- D. Management and control
- E. Compliance with State Aid, Procurement rules & publicity
- F. Cross-cutting themes Equality and Sustainable Development
